RESEARCH AND STRATEGY DELIVERY

Research/Strategy Development Programme for 2012/13 September 2012 Review

SUMMARY

The Report provides the Board with an update on progress on the Research/Strategy Development programme and seeks approval of amendments to the programme to reflect commitments made and changing priorities and funding opportunities identified since approval of the 2011/12 Business Plan at the Partnership meeting on 13th April.

DETAIL

The Partnership at its meeting of 13 April agreed the HITRANS Business Plan for 2012/13 which includes a Programme for Research/Strategy Development for 2012/13 in support of development, implementation and delivery of the HITRANS Transport Strategy.

Work is progressing on delivery of the Programme as indicated in the Appendix to the report. At this mid-point in the year the opportunity has been taken to review progress, priorities, and the level of available funding for work that can be undertaken, recognising the opportunity currently available to deliver the Conon Bridge Railway Station within this financial year as part of the mitigation measures relating to the resurfacing work to be undertaken on Kessock Bridge. The intention of the revisions is to focus expenditure on actions that support the Government and Councils in delivering the Government's overall purpose of sustainable economic growth by supporting transport improvements across the HITRANS area that deliver the Regional Transport Strategy.

The available funding for the 2012/13 Programme has been increased by £20,158 from that included in the 2012/13 Business Plan, in reflection of the overall Budget underspend in 2011/12 as reported to the Partnership at the June Meeting.

The Partnership's Permanent Advisors and Officers discussed and developed the proposed revised Programme at their Meeting in September and agreed to recommend it to the Partnership.
